

# RECORD OF PROCEEDINGS CITY OF LAFAYETTE

## PUBLIC ART COMMITTEE March 20, 2019

The March 20, 2019, Public Art Committee Meeting began at 7:00 p.m. at The Collective, 201 North Public Road, Lafayette, Colorado.

### **Call to Order**

The meeting was called to order by Barbara Rudlaff, Chair, at 7:00 pm.

Those in attendance were Barbara Rudlaff (Chair), Tara Gale (Vice Chair), Bea Glassford (Treasurer), Pamela Sherrick (Secretary), Heather Bair, Lindsey Wohlman, Josie Knapp, Lisa Michot, Susan Booker (City Staff Liaison), and Stacey Bernstein (City Public Art Coordinator).

Heidi Mallon (LCAC Liaison) and J.D. Mangat (City Council Liaison) were not present.

### **Approval of Minutes**

Bea Glassford made a motion that was seconded by Tara Gale **to approve the minutes of the February 13, 2019, meeting**. The motion passed unanimously.

### **Update on 2019 AOTS**

Stacey Bernstein informed the PAC that the 2018 Art on the Street sculptures were uninstalled on March 19 and March 20. The new 2019 AOTS sculptures will be installed starting April 2. Creation of web pages for AOTS 2019 is underway by ACRD staff. Stacey and Rachel Hanson will be working on the brochure and signage next week.

### **AOTS: See & Respond! Planning**

Stacey said that entries for the See & Respond! Competition will be accepted at the Collective throughout the summer. Volunteers for the event will be enlisted at the April PAC meeting. Judging may occur earlier than last year; but the reception date may move to Saturday 10/19 due to other events. Uninstall for the show might shift also from 11/3 to 11/4 to 11/10 to 11/11 due to Day of the Dead celebrations.

### **Update Locations for Purchased Sculptures**

This discussion was tabled until the April meeting. Susan Booker did inform the group that the sculpture My Friend Mike and Ikes from 2018 AOTS will remain at its current location at Emma Street and Public Road until a later date, although a taller pedestal can be installed to boost the height of the artwork. A new AOTS location has been added near the Distillery on Public Road. The 2019 AOTS sculpture resembling a butterfly can be installed at this location due to its smaller than anticipated size. Susan asked the PAC for suggestions on a permanent location for Rhino Iguana as the WOW museum does not have a location for it at this time.

### **Mural Grant Request by WOW Museum**

The PAC discussed a request from the WOW Museum for a \$2,500 contribution for a mural they will be installing on an exterior wall. Committee members directed Susan Booker to obtain some additional information about the mural, including the total cost, contributions obtained from other organizations, and the draft design.

### **Plans for Cassie Dedication**

Stacey Bernstein said the dedication for Cassie is planned for the week of June 17-21, pending approval of the Imagine staff and board.

### **LCAC Report**

Susan Booker advised PAC that LCAC is still looking for volunteers to serve on the Commission. Barbara Rudlaff suggested incentives be provided for volunteers in the form of Rec Center punch cards or passes. The PAC briefly discussed this suggestion and asked Susan Booker to explore this option. LCAC is holding a mini-retreat on March 23 to discuss their goals and objectives for the Strategic Plan. Jenn Olson will be facilitator for the retreat. Arts in Education grant applications are being accepted until mid-April.

### **Comp Plan Discussion**

Susan Booker informed the group that the City Council did not complete interviews yet for volunteers who will serve on the Comp Plan Committee. Due to spring break, the Council will not start interviews again until April. Susan recommended that PAC members attend at least some of the Comp Plan Committee meetings (when they commence) and talk up Art and its huge impact in Lafayette. She also recommended that everyone sign up for the newsletters on the City web site.

### **Report from ARTS !Lafayette**

Heather Bair let the PAC know that ARTS!Lafayette will be sending out a request soon for volunteers for Art Night Out this summer. She also said the nonprofit board is discussing possible fundraisers and how to spark more interest in the Connect the Arts networking event. One suggestion has been to add short talks like TED talks.

### **Adjourn**

Pamela Sherrick made a motion, seconded by Lindsey Wohlman, that the meeting be adjourned at 8:26 pm. The motion passed unanimously.
